RETENTION BONUS MEMORANDUM OF UNDERSTANDING

This Agreement is entered into between the Iftin Charter School ("ICS" or "SCHOOL") and the and ("EMPLOYEE") for the purpose of clearly defining both the SCHOOL's and the EMPLOYEE's responsibilities in relation to the EMPLOYEE'S voluntary participation in the Retention Bonus.

This retention bonus agreement establishes the terms of your continued employment with Iftin Charter School, in response to retention and staffing needs from July 1, 2022 through June 1, 2024.

RETENTION BONUS ELIGIBILITY

All current certificated staff full-time (0.9 FTE and above) employed at ICS upon signing of this MOU will be eligible for a bonus upon completion of employment within their current position through June 1, 2024.

The EMPLOYEE agrees to work at the SCHOOL for a minimum of two (2) additional full-time years.

MANDATORY EMPLOYEE REIMBURSEMENTS

The EMPLOYEE agrees to reimburse the SCHOOL if any of the following events occur:

- The EMPLOYEE voluntarily terminates employment for any reason.
- The EMPLOYEE does not work the required year(s).

Retention Bonus Amounts:

- Full-time Certificated Staff: \$5,000 bonus
- Bonus will be payable no later than September 26, 2022
