E. Title I, Part A, Basic, Increase Academic Achievement

- Winter session went two weeks with SPED and RTI students. Piloted a new curriculum. Saw 8 point improvement for those students on the MAPS Winter test.
- December 27th park picnic. Had art center, pizza, book give away. Ms. Proud says it was successful.
- MAPS testing beginning of February: saw an average 3 point improvement with 10 points being the target.

Iftin Charter School

- After school intervention 3 4:15 Mon. Thurs. Focus on reading fluency and comprehension, math, and a snack. 10 students per class maximum with about 80 attending.
- Fast For Word is being piloted. Phonics and reading assistant.
- Talk of a 4 week 4 hour summer school program possibly 5 days a week. Early July August 1st. Recommendation from Ms. Proud is to extend it to 6 or 8 weeks. 200 students possible with strong emphasis on science mostly, also math and reading.
- Academic Bee hosted at Iftin on March 16th (Saturday). Spelling Bees have been had for TK-2, 3-5, and middle school.

F. Engaging parents and families:

- Have been awarding parents at parent meetings
- March 1st started focusing more on 3rd grade student issues
- 120 students m/m referrals at the beginning. Was down to 36, is now spiking back up.
- Want to open a guidance class up to 45 students, Ms. Proud would like input.
 - Bring it up at a parent meeting
 - Need high staffing and structure. Low ratio to teacher. Backup for if they misbehave there. Seperate levels of age.
 - o Give plenty of notice and grace period then begin. Launch after break.
 - o Community service trash pickup, gardening might be too enjoyable.
- Recommend up discipline/support team. Increase class assistants. Stricter discipline procedures with consequences and parent backup.
- List disruption examples.
