CEO/Principal Report:

Mr. Yussuf shared the CAASPP 20-21 SY results with the public. The score reports will be made available early fall through the California Dashboard.

"We will be sharing individual scores with parents soon, so that they better understand their child's strengths and areas in need of improvement. Also, create opportunities to guide parents during parent-teacher conferences and resources to support them at home."

Dr. Johnson: "This level of growth is very impressive, especially after the pandemic. There were many challenges for families, many challenges for teachers, many challenges for the community. Even some of the high performing schools that my center studies. They had challenges of keeping a high level of growth last year. This is a testament to the leadership of Iftin Charter School, teachers and staff. It shows the potential of the students. Is there work to be done? Absolutely, but this is very exciting.

Joshua Eng, CSMC:

Actual to Budget:

This report is as of Aug 31st, 2022, compared against our board-approved budget on June 24th, 2022. This budget is based on 425 students enrolled and 396 ADA. This budget is subject to a negative change if the P2 ADA is not met.

YTD Revenues through Aug 31, 2022, are \$506,619 or 40.4% over our current budget due to cash being advanced earlier than expected. This is not additional/new revenue.

YTD Expenses through Aug 31, 2022, are \$747,043 or 14.6% over our current budget due to new added staff positions and summer pay costs being greater than budgeted. Also, various expenses such as Utilities, Educational Consultants, & Insurance currently trending higher than budgeted. We will continue to track expenses as months progress to see if this will negatively affect the budget.

Therefore, net deficit is or 17.3% under our current budget. This is subject to change.

Balance Sheet: As of Aug 31, 2022, we had total cash of \$1,893,871, short-term liabilities of \$763,837, and long-term liabilities of \$0. The ending fund balance is \$2,028,775.

Independent Study: Education Code section 51747 requires that governing boards adopt independent study policies containing specified elements as one of many conditions that must be met to generate funded average daily attendance for independent study.
