School data has many improvements, including 1 hour of after school intervention showing effective instruction.

March 11 we met with SDSU about professional development, vertical team work, and coaching.

March 11 we reviewed all the IEP files and completed all services.

March 11 SSC discussed appointing a new chairman, approval for changing SSC schedule to  $2^{nd}$  Friday of each month, & Title I.

Administration presented a video on the school.

Warsame: During the video, a drone shot was used, and we should utilize it in safety drills. In terms of food, let's hear what the kids want in a survey, and try to meet their needs to get our kids fed more. Let's make sure El Dorado is here for our next site visit from the district.

Proud: SELPA will review documents next week. Every single item in the files is clearly stated and appropriately attended.

Warsame: Where are we on the renewal?

Hori: There are 17 elements the state of California is seeking. The next board meeting Mr. Maani will share the information about the renewal document.

Warsame: We would like you to also emphasize media on outreach.

Proud: We invite you for tomorrow's History Bee. Mr. Udall could you share some additional information?

Udall: There are 55 kids coming to compete tomorrow from 9 am to 6 pm from around Southern California. 19 of our kids are entered and will show up. About 50% of the kids qualify for nationals in Chicago, and last year we had 3 students qualify for nationals in Atlanta. We are trying to fundraise to help all students travel.

Ali: Are there any interventions planned for the kids not improving in the data?

Proud: I suggest we continue to use fast forward, a pilot program we used during the winter break.

Mohamud: The amount of time students use also contribute to the poor data.

Ali: We need to hear a plan about improvement for all of our students.

Udall: And I suggest looking outside the box as a charter school to find the most successful method to get the strongest CAASPP scores possible.

### **III. Discussion Items**

A. 2018-19 2<sup>nd</sup> Interim Financial report (Att. 3)

Jones: This is 2<sup>nd</sup> annual report that the board must approve by March 13<sup>th</sup>. It has been submitted and you will approve this compliance report tonight. Our total revenues are 3.2 million, and our total expenses 3.08 million. Our beginning fund balance was 1.66 million unrestricted, and 216K restricted, combined to 1.88 million. Currently there are 1.91 million in assets. Iftin is doing well in terms of following the projection set last year.

B. February 2019 Financials Update (Att. 4)

Jones: We've received 7% more revenue to date, and we are under 2% on the expenses to date. We are projected to finish with a positive net income of 23K.

C. Independent Auditing Selection Certification (Att. 5)

Jones: This is the same firm from last year. The price is relatively the same.

D. CALPADS (Att. 6)

Mohamud: This is an annual submission due on the  $22^{nd}$  of March for state and federal funding. We are 80% complete, and office staff is working to submit proposal.

E. Renaming of the Library: "The Mr. Mohamed Library"

Hori: Every organization has a history, and our school opened 13 years ago, and our founders worked hard to run this school. Mr. Mohamed started with 68 students in 2006. I met with him, and he told me his goals he wanted students in City Heights to be successful. He knocked on every door in San Diego County, and we got to 185 students. When he retired, there was 345 students. Therefore, I think it's very important to rename the library after him, and he deserves it. Whatever the community says, you always have to move forward helping the kids and parents.

Warsame: I concur with Mr. Hori's comments about the importance of Mr. Mohamed. I think that when he came into the movement with the community organizers, he helped secure resources and got the school open. I think it's important to recognize the establishment of the school moving into the future, and it would be an honor to have his name and event to honor him with a celebration.
