Hassan: Did they change language on terminating contract?

Ali: I support both Joe and Rahmo, but we need to have a standard on what to do with absentees not for this topic but as a system. No one can make it to every meeting, and Rahmo is an advocate for the community. Udall is a very important bridge that connects us to the teachers and students.

Hersi: I support Joe and Faisal and advise Rahmo to be present at meetings. We had quorum issues at many meetings. I was sick one day and had to come to ensure quorum.

Abdi: Yes, I have been absent but that is going to change this time around.

Hori: I'm not a board member, but advise the reappointment of all board members tonight.

Warsame: I wasn't going to support Ms. Abdi's renewal but I don't mind joining my colleagues in support with understanding taking action if absentees becomes an issue again. Ibrahim, if
