REGULAR SESSION

I. Principal Report

Hori: There are currently 350 students. Through SDSU NCUST, admin is continuing their efforts on building relationships with students through PBIS. The key to success involves removing barriers. October 17th the school performed a CA Shakeout successfully. On October 23rd, we met with the Charter Office from the District and had a successful site visit. On October 29th, we decided on our after school program, and will present this later in the meeting. The keys will be implementation, monitoring, assessment, evaluation.

Warsame: Thank you administration for the report. We want to hear more about PBIS. We also want to hear what the parents fit into the PBIS. Do we know what the attendance of the parent

III. Discussion Items

A. Charter Renewal Petition (Att. 2)

Daughtery: We are on a roll. The CA Dashboard is updated, and many of the procedures are nearly completed. The document has been reviewed by CCSA and your legal department, and will be formatted on Monday. Much of the data shows why Iftin meets criteria to be renewed.

Udall: Shouldn't we feature the English Language Learner data that shows how much better we are than the district and state?

Daughtery: This is a subset group, and needs to be in the section that goes with this data. And as you can see, Iftin has an 89% African American enrollment, and after we get renewed, we will need to get the Hispanic enrollment closer to the district's 42%.

Udall: I recommend we set an appointment with you with the academic committee to go through the LCAP in a more detailed way. We usually feel rushed in June to go through all of it, and we added 2 regular meetings to help with the LCAP process.

Daughtery: This is a good idea, and we should start working on it for January.

Warsame: I want to thank you very much. Now the ad hoc petition committee would like to forward you some recommendations. For instance, what is our volunteer policy and should it be in the petition. We are looking to push back the approval date to give another look and want to meet Brown Act approval.

Hori: The Charter office was notified they will be delivered the petition on Monday.

B. October Financials Update (Att. 3)

Eng: We have a 200k difference in expectations, mostly due to receiving money sooner than expected, and spending money on other items later than expected. Total liabilities and assets amount to 2.1 million dollars.

Daughtery: If not updated, then on the cover page it would read "reviewed." It does not need board approval for "reviewed."

Charles: We are looking to serve 140 students based on the CAASPP and MAP assessment. There are two times from 7 to 7:50 am, and from 3 to 4:30 for 2nd to 5th grade. We are seeking to use Literacy Footprints and Do the Math. We would need 19 staff members, and for 91 days it would be about 65k.

Warsame: This after school program looks great, but we need to meet the student's needs. For example: if parents can bring their kids at 7 am, staying late might work better. But there might be a category for those that can't do either. How can we think outside the box? Are there digital options? Tailor toward local libraries?

Ali: I am glad we are having this discussion again. This is one of the ways we had better achievements last year. My concern is that we are focusing on the kid's on the next level, and we can't abandon the kids who are far behind.

Charles: We want to see that many of the interventions also continue happening in the classroom.

E. Board Membership 2 Yr. Term Update

Warsame: Mr. Hassan's term expired, and tonight he is up for renewal. Mr. Hassan, why are you interested in continuing your term?

Hassan: I have been a board member a long time, and my kids went to this school, and I am happy to see its development. I want to keep this long journey going, and improve our school to a high school and get our kids ready for college.

Ali: I am very supportive of Mr. Hassan being renewed, and he has a lot of experience in the community and the school. He welcomed me and behind the scenes he brings a lot to the table and has a lot of wisdom. I really appreciate him willing to continue this work.

Abdi: Thank you for your dedication to helping Iftin grow. You are always there to support our kids. You are always helpful when it comes to my question.

Udall: As a veteran member, I appreciate you being on the board since 2013, and I am glad you will one day replace me as the veteran board member. I do support his nomination, and thank him for serving.

Warsame: I agree with my colleagues, and as a president seeking quorum, he has always been reliable to make meetings, even coming straight from work as needed. One of the great community members who encouraged me to be one as well, and I thank him for his service.

Discussion E. Amend Principal Health Benefit Package: Employer vs Employee Contribution Warsame: Our principal put in a request to have a competitive health package, just like when we honored our teachers last year, and we have someone with Mr. Hori's character who helps kids and parents.

Abdi: Thank you for your hard work and leadership, Mr. Hori.

Warsame: We are recommending changing our employee's health package contribution. Article 2, Compensation Clause 2.2: Employer agrees to provide health benefits at cost to employee of \$450 monthly. Note: this deviates from current existing health benefit offered. No change to copays, Dental, vision plans. Subject to the Board's approval, this contract amendment shall be made effective January 1st, 2019.

Ali: I also associate with these comments and do recognize Mr. Hori's hard work and his efforts are obvious and the educational achievements and retaining teachers is bringing hope. I am supporting amending his contract.
